ARTICLES OF INCORPORATION

The undersigned, being of the age of eighteen years or more, do hereby make and acknowledge these Articles of Incorporation for the purpose of forming a non-profit corporation under the laws of the State of North Carolina, as contained in Chapter 55-A of the General Statutes of North Carolina, entitled, "Non-Profit Corporation Act", and the several amendments thereto:

- % l. The name of the Corporation is "CEDAR GROVE FIRE DEPARTMENT, INC."  $\ensuremath{\text{\tiny The}}$
- 2. The period of duration of the Corporation is perpetual.
- 3. The purposes for which the Corporation is organized are exclusively for charitable purposes as follows:
- (a) To buy, lease, or otherwise acquire any fire fighting equipment, including fire trucks and other fire fighting apparatus;
- (b) To acquire by purchase or lease or otherwise, property, both real and personal, for the purpose of operating and maintaining a fire department;
- (c) And to do and perform any and all acts necessary or beneficial to the operation of a fire department;
- 4. The Corporation shall have one class of members, being all resident freeholders, living in that area known as Cedar Grove Fire Protection District; and each qualified member shall be entitled to the right to vote.
- 5. The Directors of the Corporation shall be elected by the members of the Cedar Grove Fire Protection District as provided by the by-laws.
- 6. No part of the net earnings of this Corporation shall inure to the benefit of any private member or individual.
- 7. The initial registered office of the Corporation shall be Route 1, Box 83-A, Hurdle Mills, North Carolina, Orange County; and the name of its initial registered agent at such address shall be EDGAR LONG.
